The purpose of the public hearing is to solicit public comment on a proposed amendment to the Fiscal Year 2023-2024 Budget. The Lee County School Board has carryover funds from the prior fiscal year in the amount of \$3,106,056.38 and is requesting re-appropriation of this amount to the current fiscal year budget. The \$3,106,056.38 represents unspent State Direct Aid to Public Education funds received in Fiscal Year 2023-2024 and is eligible for re-appropriation to the current fiscal year.
