CENTRALIZED ACCOUNTING

Mr. Kidwell asked why the School Board would not want to help in this process if these functions were consolidated into the Administrator's Office.

Mr. Poe explained that this would not be required of them and they may choose to spend the money in other areas. He added that even if they did choose to help with this function, the net effect on savings would be zero as the salaries would still be paid.
