The Lee County Board of Supervisors will hold a Public Hearing on September 15, 2015 at 5:00 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on a Special Use Permit request. Ronnie Rhoten has requested a Special Use Permit to allow replacement of a singlewide manufactured home with a larger singlewide manufactured home in a V-C, Village Commercial district. The property is located on the east side of US Hwy. 23 at mile marker 28.6 (Tax Parcel 18-(A)-76) and consists of approximately 0.89 acres of land.

Drive (Tax Parcel 36-(22)-1) and consists of 8.119 acres and is commonly known as the former Lee Regional Medical Center.
