The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, January 16, 2018 at 6:00 p.m. in the General District Courtroom of the Lee County Courthouse in Jonesville, Virginia. The purpose of the Public Hearing is to receive public comment on the proposed fencing law for Lee County, Virginia. If adopted, the boundary line of each lot or tract of land within the County of Lee would be declared to be a lawful fence as to any and all domesticated livestock referred to in Code of Virginia, Section 55-306. Further, it shall be unlawful for the owner or manager of any animal or type of animal described in Section 55-306 to permit such animal to run at large beyond the limits of his lands within the County of Lee, Virginia
