Melanie Salyer has applied for a Special Use Permit to allow a professional and administrative office in a V-C (Village Commercial) District. The property is located at the intersection of Rt. 726 (Chris Barney Rd) and Rt. 619 (Orr Rd) in the Dryden Community and consists of .29 acres of land (Tax Parcel 25A-(5)-BK6, 1-4).
