The Lee County Board of Supervisors will hold a Public Hearing on December 15, 2020 at 4:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on the following proposed Zoning Text Amendment:

To allow recovery homes for substance abuse (including alcohol) victims, operated by a faith-based organization and not licensed by the state, which may offer workforce education and/or training, counseling services, and life skills to assist in transitioning into a productive member of society, but no medications other than those prescribed by a licensed physician for medical reasons and not as a treatment for substance abuse. A recovery home facility would house no more than 16 residents at any one time. Recovery home facilities would be allowed by Special Use Permit only.

The Lee County Board of Supervisors will hold a Public Hearing on December 15, 2020 at 4:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on a proposed ordinance to adopt Virginia Code Title 18.2., Crimes and Offenses Generally, and Virginia Code Title 46.2., Motor Vehicles, in their entirety. The adoption of these State Code Titles will authorize the County of Lee to enforce and charge violations of these titles as local offenses.
