A. SPECIAL USE PERMIT

The Lee County Board of Supervisors will hold a Public Hearing on January 19, 2021 at 4:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on a proposed Special Use Permit. John & Barbara Surber/Demas Yoder have applied for a Special Use Permit to allow a retail store in an A-1, Agricultural District. The property consists of approximately 11.0 acres and is located on the North side of US Highway 58 approximately 0.5 miles from the East and West intersections of the Rte 899 (Beech Springs Rd), Tax Parcel No. 50-(A)-20A.

B. PROPOSED AMENDMENT TO FY 2020-2021 BUDGET

The Lee County Board of Supervisors will hold a public hearing on Tuesday, January 19, 2021 at 4:30 p.m. in the General District Courtroom of the Lee County Courthouse, Jonesville, Virginia. The purpose of the public hearing is to solicit public comment on a proposed amendment to the Fiscal Year 2020-2021 Budget. The Lee County School Board has requested a supplemental appropriation in the amount of \$3,494,052.61. The requested appropriation consists of \$1,383,533.82 from CARES Act Funds; \$545,138.79 from Elementary and Secondary School Emergency Relief (ESSER) Funds and the Governor's Emergency Education Relief (GEER) Funds; \$752,857.00 from USDA Rural Development's Rural Utilities Service (RUS) Distance Learning and Telemedicine (DLT) grant funds; \$512,523.00 from Coronavirus Relief Funds (CRF); and \$300,000 from loan funds for the Dryden Elementary Roof Replacement project.

C. PROPOSED ROAD ABANDONMENT

Notice is hereby given that the Lee County Board of Supervisors will hold a Public Hearing on Tuesday, January 19, 2021 at 4:30 p.m. in the General District Courtroom of the Lee County Courthouse, Jonesville, Virginia. The purpose of the Public Hearing will be to receive public comment on the proposed abandonment of an unnamed street on the north side of the unincorporated town of Rose Hill. The street lies in the Rose Hill Magisterial District of Lee County, Virginia, approximately 100 feet east of Short Ridge Drive. The unnamed street is 30 feet wide and runs in a northerly direction from Highpoint Road approximately 762 feet. The unnamed street is shown on a sale plat of the Jerry and Suzanne Brittain Property as recorded in the Lee County Circuit Court Clerk's Office in Map Cabinet AA, Slide 23. If the abandonment is approved, title to the street will be transferred to the adjacent property owner(s).
