A. PROPOSED AMENDMENT TO COURTHOUSE SECURITY FEE ORDINANCE ENACTED PURSUANT TO TITLE 53.1, CHAPTER 756 (§53.1-120) OF THE CODE OF VIRGINIA, AS AMENDED

The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, March 16, 2021 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia. The purpose of the Public Hearing is to take public comment on a proposed amendment to the Courthouse Security Fee Ordinance which imposes a fee of \$13.00 as part of the costs in each criminal or traffic case in the General District or Circuit Courts in the County of Lee, Virginia. If adopted, the amendment will also impose the fee in the Juvenile and Domestic Relations Court of Lee County, Virginia.

B. PROPOSED ABANDONMENT OF TWO STREETS

The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, March 16, 2021 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse, Jonesville, Virginia. The purpose of the Public Hearing is to receive public comment on the proposed abandonment of two streets shown on a plat of the Richmond Heights Subdivision dated July 22, 1967 and recorded in the Lee County Circuit Court Clerk's Office Plat Cabinet AA, Slide 18, and lying in the Jonesville Magisterial District of Lee County, Virginia adjacent to the eastern border of the Town of Jonesville and more particularly described as follows:

- A portion of Cedar Street beginning at State Route 864 (Bus Shop Rd) and running northerly approximately 440 feet to its intersection with Sinking Springs Drive.
- Valley Street beginning at Cedar Street and running westerly approximately 680 feet to Oak Street.

If the abandonment is approved, the streets will revert back to the adjacent property owner(s).

C. PROPOSED ROAD ABANDONMENT

The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, March 16, 2021 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse, Jonesville, Virginia. The purpose of the Public Hearing is to receive public comment on the proposed abandonment of 1.1 miles of State Route 739 (Harris Hollow Rd and Hunting Club Rd) from State Route 783 to .95 miles south of State Route 617 in the Jonesville Magisterial District of Lee County, Virginia. The proposed abandonment also includes the abandonment of a pedestrian bridge over the Powell River. If the abandonment is approved, the roadway will revert back to the adjacent property owner(s).
