The purpose of the Public Hearing is to take public comment on a proposed amendment to the Ordinance establishing the boundary lines of election districts, boundary lines of election precincts, and polling places for each precinct in the County of Lee, Virginia. The amendment is required to adjust for population changes as determined by the 2020 Census and establishes the proposed new election districts and precincts for all elections.
