The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, June 20, 2023 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on a Rezoning request. Kenton Arthur Edds has applied to rezone property that is currently zoned R-1, Single Family Residential and V-C, Village Commercial to R-2, General Residential. The property consists of approximately 1.2 acres of land and is located on the South side of Dr. Thomas Walker Rd (Old U.S. 58) and on the West side of Wild Rose Heights Rd in the Rose Hill Community (Tax Parcel #46A-2-51-53, 51A-55A, 51B-57B, 51C-58C.

B. PROPOSED AMENDMENT TO AND RE-ADOPTION OF THE TRANSIENT OCCUPANCY TAX ORDINANCE (Enclosure)

The Lee County Board of Supervisors will hold a Public Hearing on Tuesday, June 20, 2023 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia. The purpose of the Public Hearing is to take public comment on the proposed amendment to and re-adoption of the Transient Occupancy Tax Ordinance. The current ordinance taxes only short-term (less than 30 days) rentals at a boarding house, hotel, motel or travel campground at a rate of two percent (2%) of the rental fee. The proposed amendment would tax all short-term (less than 30 days) rental accommodations at a rate of five percent (5%) of the rental fee provided, however; the tax will not be imposed on any rental accommodation located within any town that has imposed a tax on transient occupancy.

C. PROPOSED BUDGET FOR FISCAL YEAR 2023-24 (Enclosure)

The Lee County Board of Supervisors will hold a Public Hearing on the proposed County Budget at 5:30 p.m. on June 20, 2023 in the General District Courtroom of the Lee County Courthouse in Jonesville, Virginia.
