SOLID WASTE

Gary Collingsworth, Transfer Station Superintendant, reported that 1,249.12 tons of garbage and 27.31 tons of tires were taken in at the Transfer Station. His department

Mr. Mosley asked about the truck repairs.

Mr. Collingsworth stated that a new radiator has been installed, and the emission and engine components have seemed to level out.

Mr. Slemp asked if the Transfer Station is ready to start hauling gravel.

Mr. Collingsworth stated that they are to get the projects completed then they will be ready to haul.

has been preparing the convenience centers for the winter, cutting brush, repairing busted water lines and clearing land. The department will work on the Scale House; Forestry

shed and repair dumpsters in the coming months.

ANIMAL CONTROL

Allen Fortner, Animal Control Officer, reported that in October his department received 279 calls and 92 through dispatch, picked up 38 strays, 22 owner surrenders, 4 seized and 1 bite case. Twenty dogs were reclaimed, 12 were adopted, 23 were transferred to rescue, nine were euthanized and one is still in the pound. One issue that receives many complaints is agriculture animals running free or being in the highway and asked the Board to consider adopting a code on fencing laws to address this issue, and to look into charging a fee for owner reclaims to help the County offset some of the expenses of housing the animals. He stated that both Animal Control Officers are sworn deputies and they have to respond with the County Deputies on calls if there is an animal at the location, he asked that the Board consider the starting salary of a County Deputy and think about giving the Assistant Animal Control Officer a raise to a comparable salary. He also added that he has been in contact with the Wise County Animal Control Office, and stated that Wise County has a \$4.00 a day fee for any animal that is reclaimed by the owner, and asked that the Board also consider adopting a fee to help with the expense of holding a dog.

LITTER CONTROL

Josh Fleenor, Litter Control Coordinator, reported that there were 150 people
enrolled in the Community Service Program, there were 84 participants for a total of
1196 hours, 16 participants completed the program and 27 were removed for inactivity.
He is working on an illegal dumpsite map, with 11 sites and 23 roads identified, and
cleanup will get started after the Thanksgiving holiday. He is working on complaints he
has received in several areas.

Mr. Mosley advised Mr. Fleenor to check with the Treasurer's Office about who pays taxes on the property in Cane Creek, and asked him to check on the garbage that is setting at Bedrock Road.

Mr. Fleenor stated he would look into that.

PARENTS ADVOCACY AND ADVISORY COUNCIL TERESA BARRINGER

Teresa Barringer, Parents Advocacy and Advisory Council (PAAC), addressed the Board about the possible closure of the Southwest Virginia Training Center, which is a training center for intellectually and developmentally disabled adults that Lee County is eligible to send residents. She stated that in August of 2008 the Department of Justice

began an investigation based on a complaint out of the Central Virginia Training Center that an intellectually challenged individual was able to move out of the facility and had not been moved out. In August of 2010 the State of Virginia was put on notice that the DOJ was expanding the investigation to all five centers in the State. In February of 2011, the DOJ issued the finding that the Training Centers were not doing enough for the disabled persons to move them into the community. In August of 2012, a court ruling stated that nothing in the decree of the DOJ settlement agreement compels Virginia to close any facility. It is in the hands of the General Assembly or the Governor to appropriate the funds to operate some or all of the Training Centers. The previous Governor signed a ruling that all but one of the Training Centers would be closed with the one to remain open being in Chesapeake. Ms. Barringer is asking the Board to adopt a Resolution asking that the Southwest Virginia Training Center remain open.

Mr. Mosley stated that the County needs to try to help these people.
Ms. Rowe stated that this is a subject that in near and dear to heart, and she appreciates Ms. Barringer traveling this far, and will support this Resolution.
Mr. Bailey asked if the Governor or General Assembly has offered any explanation.

ODOR ISSUES AT SOCIAL SERVICES BUILDING

Mr. Poe reported that he has received complaints for the past few months of off-and-on odor issues at the Social Services building. It has been tentatively identified as "dirty sock syndrome" which affects heat pump units, a fairly common problem, especially noticeable in spring and fall when the system may be required to provide heating in the morning and cooling in the afternoon, or alternating from heating on cool days and cooling on warmer days. Cleaning the coils will temporarily eliminate the odor and that process has begun. A more permanent solution is the installation of ultra violet lights on the coils. There would need to be a total of seven light units to cover all HVAC units in the building. Southwest Heating and Air Conditioning has provided a price quote for these in the amount of \$4,900. Mr. Poe believes it would be advisable at this time to install the UV lights to prevent future occurrences. The UV lights are not guaranteed but are expected to eliminate most, if not all, odor problems at the building.

Since a skunk and ammonia odor has been reported, Mr. Poe has requested Jack Tolbert with the Virginia Department of Emergency Management to again check the building to perform some air tests.

CUMBERLAND AIRPORT COMMISSION WITHDRAWAL

Mr. Poe stated that the Cumberland Airport Commission, which oversees the operation of Lonesome Pine Airport in Wise, was created in 1958 by several surrounding localities to promote construction of an airport in the coalfields region. Since that time, several airports have been constructed; however, Lee County is still technically a member of the Commission. To Mr. Poe's knowledge, Lee County has not participated in the Commission since construction of the old airport at Pennington Gap in 1962 which was subsequently replaced in 2002 by the current airport facility west of Jonesville. Since there apprears to be no advantage or interest for Lee County to remain a part of the Cumberland Airport Commission, Mr. Poe recommends the Board consider withdrawing. The process for withdrawal is stated in the authorizing legislation as follows:

"Any county, city or town creating the commission may withdraw therefrom upon giving one year's notice to the commission and to all other participating counties, city and towns..."

Mr. Poe prepared a resolution for the Boards consideration stating the County's intent to withdraw from the Cumberland Airport Commission which would serve as formal notice to all other participating localities and would result in our formal withdrawal one year from the date of adoption.

Mr. Mosley stated that there is actually a seat on this Board for Lee County but it is of no benefit, and if the County withdraws that seat can be awarded to a member of Wise County.

It was moved by Mr. Mosley, seconded by Mr. Slemp, to adopt the following Resolution. Upon the question being put the vote was as follows.

WHEREAS, at Regular Meeting on November 5, 1958, the Lee County Board of Supervisors adopted a resolution declaring the need for an airport commission to be created for the purpose of establishing and operating one or more airports or landing fields for the counties of Wise, Dickenson, Lee and Russell, the City of Norton, and the towns of Appalachia, Big Stone Gap, Wise, Pound, Coeburn, St. Paul, Clintwood, Haysi, Jonesville, Pennington Gap, Ewing, Rose Hill, and Lebanon; and

WHEREAS, this resolution the County of Lee became a founding member of the Cumberland Airport Commission; and

WHEREAS, a new airport was constructed west of Jonesville in 2002 to replace the small airport at Pennington Gap and serves the aviation needs of Lee County and surrounding areas including portions of Tennessee and Kentucky; and

WHEREAS, the Lee County Board of Supervisors sees no need or advantage for Lee County's continued membership in the Cumberland Airport Commission;

NOW, THEREFORE, BE IT RESOLVED, the Lee County Board of Supervisors hereby gives notice to all other counties, city and towns participating in the Cumberland Airport Commission of its' desire and intent to withdraw from the Commission.

BE IT FURTHER RESOLVED, this Board understands that notice is to be given to all other participating counties, city and towns and that this withdrawal will be effective one year from said notice.




