MEETING CALLED TO ORDER

The meeting was called to order at 5:06 p.m.

DEPARTMENTAL REPORTS

ANIMAL CONTROL

Allen Fortner, Animal Control Officer, reported that his department received 246 calls at the Pound and 71 calls from the Sheriff's Department, collected \$175 in

restitution, took in 37 strays, 33 owner surrenders and had one bite case. He is continuing to work with the LMU Veterinarian School on housing some of the animals, and with the citizens to get their dog's rabies tags.

Mr. Mosley asked how the new employee was doing. Mr. Fortner stated that he is doing well. Mr. Bailey asked what percentage of dogs were being adopted.

Mr. Fortner stated that the percentage of adoption was probably not even 10%, but since he has started using social media to get pictures of dogs out, the adoption rate is increasing. Last year there were around 1,000 animals picked up, 170 of those were reclaimed by the owner, 5% to 10% were adopted and about 75% went to Lee Fosters.

LITTER CONTROL

Josh Fleenor, Litter Control Coordinator, reported that there were 125 people in the Community Service Program with 76 participating; the participation rate is down since last month. He stated that he has submitted the DEQ grant, and has worked at Lee High School and would be putting recycling bins at the athletic fields. He conducted some roadside cleanups in the Sugar Run and Campground Road areas. He will be picking up old printer cartridges for recycling, and he met with Lee County Public School's cafeteria staff about recycling the cardboard that comes though the cafeterias.

Mr. Crabtree entered the meeting at 5:14 p.m.

Mr. Fleenor stated that he worked on the Outdoor Classroom and checked on several complaints.

Mr. Mosley asked about the houses on Town Branch and Cane Creek.

Mr. Fleenor stated that he is working on those.

Mr. Slemp asked when the shredded paper and printer cartridges could be picked up from his office.

Mr. Fleenor stated that was on his list to get next week.

Ms. Rowe stated that there were several printer cartridges at her office that could be picked up also.

TRANSFER STATION

Gary Collingsworth, Transfer Station Superintendant, reported that there was 1,324.29 tons of garbage and 8.38 tons of tires picked up in July. He stated that once the open position is filled, his department would be able to get to the additional projects that have been on the schedule. He added that there have been dumpster fires and a lot of clean up at the Hurricane Bridge site. His department has been working at the Airport to prep for the RAM event next month.

Mr. Bailey stated that there was gravel on top of the roof at the Thomas Walker Pool from people slinging them by doing donuts in the parking lot and asked if the security cameras would have been able to pick that up.

Mr. Collingsworth stated that as long as he has a date he could go back and review the video.

FORESTRY DEPARTMENT BUILDING

Mr. Poe reported that the building used for offices by the Forestry Department and the building used to store their equipment are some distance apart. Mr. Collingsworth has proposed to building a new pole building near the offices for them to store their equipment, and the Transfer Station use the other building to park their trucks, with the cost of materials being around \$13,800 and all labor done in house.

Mr. Slemp asked the size of the building.

Mr. Collingsworth stated that it is 30' x 40' and has two bays.

Mr. Poe stated that the cost to construct a new building would be added to the construction cost of the new Transfer Station.
