Ms. Seals has been working with Harlan to extend the 421 yard sale into Lee County, the ATV Trail as well as walking, hiking, biking, and horseback trails connecting three states.

ECONOMIC DEVELOPMENT

Mike James, Economic Development Director, reported that he hosted a job fair on August 11, 2015 with 160 job seekers, 17 employers and 3 state agencies. The Industrial Development Authority continues to host a spotlight business every month. Mr. James has met with four current or potential business owners about their plans, and a couple of those are almost ready to move forward. The Planning Commission will restart the zoning map review in October. He added that his department has issued 30 zoning permits, 2 variances and he made 4 property visits.

Mr. Mosley asked how many new jobs Taco Bell created.

Mr. James stated around 25 to 30.

Mr. Mosley asked if Mr. James had been in contact with the Assisted Living company.

Mr. James stated he has but will need to wait on an official announcement for the open date for the hospital before any commitments will be made.

Mr. Bailey stated that the importance of a hospital goes beyond urgent care. That is the reason this Board has fought so hard to get this hospital back.

WOODWAY HOUSING & SEWER GRANT APPLICATION

Mr. Poe stated that the Department of Housing and Community Development recently announced a new pilot grant program called the Vibrant Communities Initiative that could provide up to \$2.5 million for a project, but it did require a 25% local match. The total project cost for just the sewer project is about \$6.5 million. The process is not far enough along to be able to prove the other funding sources. At this point in time, the group feels it's best to submit a standard Community Development Housing Block Grant application in March of next year to begin the housing rehab work.

NEW ABSENTEE CENTER VOTING MACHINE

Mr. Poe stated that within the past year the State Board of Elections has deemed certain types of voting machines to be out of compliance with state requirements. Those used by Lee County were not on the list of non-complaint units but the touch screen style of machines is under review. Recently, the State Board of Elections advised that they would provide a one-time reimbursement of \$3,500 toward the purchase of one new style machine for use in the absentee center.

The Electoral Board and Registrar selected a fully compliant unit from Atlantic Election Services, Inc. at a total cost of \$8,625.00. With the state reimbursement, the actual local cost will be \$5,125.00. There was \$16,000 budgeted for new electronic poll books but the State has now provided those units at no cost so these funds can be used to cover the expense this machine. The purchase of this machine does not obligate the County to use the same units in all locations but will give us the opportunity to test this style of machine to determine if that is what is desired at some point in the future if the state should outlaw the touch screen machines.

The Personal Property Tax Relief Act provides for State reimbursement of a portion of the tax on personal automobiles. The percentage of relief must be re-calculated each year in order to account for changes in the total number and value of vehicles eligible for relief. The percentage of relief for the 2015 tax year has been calculated at 66.20%. The Board will need to pass a Resolution to enact this rate of relief for the 2015 tax year.

It was moved by Ms. Rowe, seconded by Mr. Crabtree, to adopt the following Resolution. Upon the question being put the vote was as follows.

RESOLUTION 15-029

WHEREAS, the Personal Property Tax Relief Act of 1998, Va. Code 58.1-3523 et seq. ("PPTRA"), has been substantially modified by the enactment of Chapter 1 of the Acts of Assembly, 2004 Special Session I (Senate Bill 5005), and the provisions of Item 503 of Chapter 951 of the 2005 Acts of Assembly (the 2005 revisions to the 2005-06 Appropriations Act, hereinafter cited as the "2005 Appropriations Act"); and

WHEREAS, these legislative enactments require the County to take affirmative steps to implement these changes, and to provide for the computation and allocation of relief provided pursuant to the PPTRA as revised; and

WHEREAS, these legislative enactments provide for the appropriation to the County of a fixed sum to be used exclusively for the provision of tax relief to owners of qualifying personal use vehicles that are subject to the personal property tax on such vehicles;

NOW, THEREFORE, BE IT RESOLVED, by the Lee County Board of Supervisors that qualifying vehicles obtaining situs within the County during tax year 2015, shall receive personal property tax relief in the following manner:

- Personal use vehicles valued at \$100 to \$20,000 will be eligible for 66.20% tax relief;
- Personal use vehicles valued at \$20,001 or more shall only receive 66.20% tax relief on the first \$20,000 of value; and
- All other vehicles which do not meet the definition of "qualifying" (business

use vehicles, farm use vehicles, motor homes, etc.) will not be eligible for any form of tax relief under this program.

SOCIAL SERVICES SIGNS

Mr. Poe reported that he had received a request to replace the Social Services sign and had contacted the sign company in Wise that made the County Welcome signs. The sign would be 5' x 4' not including the logo; the sandblasted signs would be \$2,600, the aluminum background with vinyl lettering would be \$850. Adding the Virginia seal would be an extra \$75.

Mr. Mosley questioned the need for a double-sided sign and stated that if it was turned at an angle, it could be seen from both directions.

It was moved by Ms. Rowe, seconded by Mr. Crabtree, to get a one-sided blue sandblasted sign for Social Services. Upon the question being put the vote was as follows.

OFFICE OF SURFACE MINING PROPOSED STREAM PROTECTION RULE

Mr. Poe reported that there is a public hearing tonight at Mountain Empire Community College regarding OSM stream protection rule. The comment period ends October 26, 2015. There will be six or seven nationwide, but they will take written comments and that can be done online. He provided information to the Board for their review.

EXTENSION OFFICE BUILDING

Mr. Poe stated that he had spoken with the Architect about the Board's concerns on the Extension Office Building. The Architect has made changes to the plans that moves the expansion to the west side of the building. In the end, this will be a better fit. Mr. Poe recommends advertising for bids when the architect gets everything completed.

It was the consensus of the Board to move forward and advertise for bids on the Extension Office Building.

INTERVIEWS FOR BUILDING OFFICIAL

Mr. Poe stated that the deadline for applications for the Building Code Official would be September 21, 2015. He stated that applications would be mailed out to the Board on September 22, 2015. An interview date would need to be set.

It was the consensus of the Board to hold interviews for the Building Code Official on October 7, 2015 beginning at 4:00 pm.

ATV TRAILS

Ms. Rowe asked Mr. Poe if he had been contacted by Chuck Riedhammer regarding additional funds needed for the completion of the ATV trail project.

Mr. Poe advised that he had emailed him regarding documentation for match funds for the Tobacco Commission grant. TIC grant did not require an actual match but we provided a list of leverage for the grant. We have \$50,000 budgeted for the trail that was intended as one half the required match for the DCR grant if the Town actually receives those funds.

Ms. Rowe stated that if the existing budgeted funds are spent now that would meet the DCR requirements.

Mr. Poe stated the environmental studies were conducted for those portions of the property that the DCR funds would be spent on and we could not spend match funds in areas not on the environmental study areas.

Ms. Rowe stated that the Authority needed the additional funding in order to complete the trail and get it open on time.

Mr. Poe explained that he was not opposed to spending the funds to complete the trail but he wanted the Board to understand that if the funds were spent for additional work now, it will not be available to match the DCR funds should the Town receive them.

It was moved by Ms. Rowe, seconded by Mr. Mosley, to use \$14,000 of the budgeted funds for the ATV Trail to complete the Tobacco Commission grant portion of the trail. Upon the question being put the vote was as follows.

Prior to the vote, Mr. Mosley asked if the budgeted funds were intended for the DCR match.

Mr. Poe advised that it was.

Mr. Mosley stated if the DCR funds do come through and they ask for \$50,000 match from the County, he is only in favor of providing the balance of the budgeted funds at that time.
