The Lee County Board of Supervisors and Lee County Planning Commission held a joint public hearing on Tuesday, October 18, 2016 at 6:00 p.m. in the General District Court Room of the Lee County Courthouse in Jonesville, Virginia. The

purpose of the hearing was to solicit input on a rezoning request from Stacy Estep Munsey to rezone property that is currently zoned A-1 (Agricultural District) to B-1 (Limited Business District). The property is located in the Ewing Community and consists of 2.0 acres of land. (Parcel # 63-(A)-15). Property is located on the South side of Wilderness Rd. approximately 6/10 mile west of Chadwell Station Rd. (Rt. 684).
Mr. Poe stated that typically this would be viewed as spot zoning; however, in this instance there was a business that existed prior to zoning being adopted in Lee County. It's being looked at that this was an error from the original adoption of the zoning map in 1993, and to correct that by rezoning this parcel as B-1 Business.
Ms. Munsey stated that when she checked into this she was shocked that this property was zoned A-1 since the property had a business on it for over 50 years.
Mike Brindle, Planning Commission Chairman, stated that this property should not have been A-1 to begin with and it needs to be rezoned to B-1.


