VICTIM WITNESS ADVOCATE GRANT APPLICATION AND PROPOSAL

Mr. Poe reported that he had received a letter from the Sheriff's Office stating that the Victim Witness Advocate Grant will be provided additional funding for Fiscal Year 2017. The grant application is being prepared now and is due on April 18. The grant amount is going to almost double, and it is anticipated that the funds will be there in additional years as well. Mr. Poe is asking approval from the Board to submit this grant, and there are no local funds in this grant. Right now, there is only one office, and when the grant funds double, there will sufficient funds to hire a second person. There is not additional office space for the second person, so the proposal is to renovate the Law Library and create two offices with a small waiting area. Mr. Poe stated that there are

two critical issues that need to be dealt with, one being the heating and cooling, which is now provided by a through the wall hotel style unit. When the offices are petitioned off the unit cannot be used unless a second one is added for the second office by cutting an opening through the wall of the Courthouse. The other option is to put a ductless split unit and locate the outside unit on the roof. At this point, it looks like all the work could be completed for around \$15,000. The old windows will also need to be replaced because they are old single pane windows and they don't keep out heat, cold or noise. The grant funds that begin July 1 would allow for the cost of renovations to make suitable office space.

NEW POLICE CRUISER PUSH BUMPERS

BUDGET WORKSHOP

Mr. Poe stated that the budget is presented as departments and agencies have requested, no cuts or changes have been made. The budget requests exceed revenues by \$1,669,849.00. The budget proposal is not fully complete; work is still being done on the Victim Witness Grant and on the revenue side. The numbers from Social Services is a rough estimate and the School Board budget is incomplete at this time, the State estimate for the Required Local Effort has been used. General Fund revenues are up overall about 1%, the only bad thing about that is, the real property value is up about 7%, which means it is down in other places. In the budget right now are capital requests of approximately \$1,150,000. Some of the major items include \$250,000 renovation of the Circuit Courtroom and District Court Clerk's Office; \$125,000 for exterior repairs and maintenance; \$30,000 for demolition of the Extension Office Building; \$80,000 Site Development and paving for additional parking; \$187,885 New Voting Machines; \$120,000 New Police Cruisers; \$52,000 for 911 computers and consoles; \$31,000 for New Truck/tools for Litter Control; \$26,000 for Transfer Station office build out; \$5,000 for large animal trailer for Animal Control; \$210,000 for Transfer Station 4 WD pickup truck and snow plow; 4 WD tractor; scale house building, equipment storage shed, and new convenience center at Olinger.

Mr. Poe stated that within these requests there are additional salary requests of \$213,000 including Constitutional Officers. The State Compensation Board will be providing a 2% raise for all Comp Board funded positions effective December 1, 2016. A 2% increase for all full time county positions, including the four county funded positions in the Commissioner and Treasurer's offices, would average out to \$.30 per hour plus fringe benefits for a total cost of approximately \$25,000 for a full year. A similar increase for part time positions would cost approximately \$7,000. School Board funding as listed is the state calculated Required Local Effort only as we have not received a proposed budget yet. It is based on a state projected Average Daily Membership (ADM) of 2,980.75 students. If the school system uses a higher projected ADM, our local cost increases as well. The Composite Index for school funding drops to .1701 effective July 1, 2016, down from the previous rate of .1886. The school system will also have Federal and other locally generated funds to add to the state dollars.

The Budget printout will show three prior years history, the current 2016 budget showing the adopted budget, the amended amount and the amount spent, and the column showing the department request. The next step Mr. Poe will take will be to go department by department, line item by item and make adjustments. The bigger issues for the Board will be salaries and capital projects. Mr. Poe will try to be conservative on the Revenue side, he will review the revenues a couple times and adjust accordingly.
