#### CORP OF ENGINEERS AGREEMENT FOR WESTERN LEE SEWER

The local match for project construction is anticipated to come from the Virginia Tobacco Commission, ARC, CDBG and other possible funding sources. Construction is not expected to being until 2018 or after. In order to move the project forward and allow the Corp to begin design of the system, this agreement must be approved. He added that the Western Lee Sewer project is very much needed in order to further development of that portion of the County.
