He recommends keeping the May 23rd date and using it as a budget workshop if the joint meeting is postponed.

UNFENCED WASTE COLLECTION SITES

Mr. Poe reported that the County currently has four unfenced waste collection sites at Hurricane Bridge, Intersection of Route 70 and Route 612, Route 606 and Olinger. For several years there has been problems at most of these sites with illegal dumping and fires. The Hurricane Bridge site has had the most fires and there has also been complaints from DEQ regarding waste going into the river. The Olinger site is also plagued with heavy dumping of tires and contractor waste which may partly come from Wise County. None of these sites are large enough to fence and will continue to cause problems until they are closed or moved to a fenced site. All attempts to find alternative property for these sites have been unsuccessful. In addition to these sites, there has also been heavy vandalism at the Sugar Run site with the building and electrical wiring damaged. This site is manned but has only five dumpsters on site and is not heavily used. -----

Mr. Smith asked how close to other sites are the people that this will effect.

Mr. Poe stated that in some areas there will be complaints, but in Jonesville and Flatwoods there is a lot of overlap.

Mr. Leonard stated he is concerned with sites being closed and trash still being dumped at the locations.

Mr. Poe stated that VDOT has worked in the past to trench the property where there is no access.

Mr. Leonard asked about the 606 site and the Old Dominion Property.

Mr. Poe stated that he has three contacts with Old Dominion and has not been successful with getting the deed completed.

TOWN OF PENNINGTON GAP TRAILS

Mr. Poe reported that Tina Rowe with the Town of Pennington Gap had been in contact with him about the Trails Project. The County and Town of Pennington Gap co-sponsored the project and halved the local funding. A few years ago the County appropriated \$63,500.00 to the project, \$14,000 was used for an environmental study and \$14,000 was given to the Trail, leaving \$35,500.00 unused. The Town of Pennington has fronted all of the money and due to federal audits with DCR they are unable to drawdown any grant money. The Town of Pennington Gap is asking that the County give them \$34,000.00 to complete the local match. This amount would need to be reappropriated.
