CONSULTING ACCOUNTING SERVICES PROPOSALS

Mr. Poe stated that he was recently notified that the firm that has provided consulting accounting services for the past twelve years would not be able to continue to do so due to a staff shortage. He advertised for these services with proposals being due last Thursday. The sole proposal received was from Thrower, Blanton and Associates, P.C. of Norton. Although a smaller firm, as of July 1 they will be merging with the firm of Roderfer and Moss of Kingsport and should have sufficient staff to provide these services.

Their anticipated fee range for these services is between \$24,500 and \$26,500 per year. Since these services are need for the year ending this week, Mr. Poe recommends awarding a three-year contract with the option to renew for two one-year extensions.

SCHOOL RESOURCE OFFICER GRANT AWARDS

Mr. Poe reported that he received notification earlier this week of the award of three School Resource Office/School Security Officer grants, each in the amount of \$57,390.00 which is comprised of \$47,323.00 in State funds and \$10,067.00 in local funds. Two of these grants would be used to replace funding for existing positions and one will be used to hire a new officer. In the past couple of years, the School Board has reimubrsed\$36,000.00 of the total cost of the SRO positions and that has been included in the FY 2019-2020 budget. Since that is more than the local match for all three of the new grants, there should be no need for any additional local funding.

After a brief discussion with the School Superintendent, it was the consensus of the Board to used School Board reimbursement for the local match.
