PROPOSED ROAD ABANDONMENT

The Lee County Board of Supervisors held a Public Hearing on Tuesday, March 16, 2021 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse, Jonesville, Virginia. The purpose of the Public Hearing was to receive public comment on the proposed abandonment of 1.1 miles of State Route 739 (Harris Hollow Rd and Hunting Club Rd) from State Route 783 to .95 miles south of State Route 617 in the Jonesville Magisterial District of Lee County, Virginia. The proposed abandonment also includes the abandonment of a pedestrian bridge over the Powell

property owner(s).
The Chairman opened the floor for public comment and advised that each speak would be limited to a three-minute time-period for individuals, and five-minute time-period for a group.
Kena Sizemore, Estes Brother's Property Manager, made a presentation to the Board on the proposed changes that would be made to the property if the Board votes to abandon this road and on the changes that have already occurred at the Steep Rock location. She asked the Board to approve that abandonment of State Route 739.
Sue Ella Kobak, Dryden, addressed the Board in opposition of the proposed road abandonment.
Ben Richmond, Jonesville, stated that he has been using the ford for 50 years to ride horses and to get in and out of the river. He stated that this is not abandoned property and asked the Board not to close the road.
Wayne Nickodam, Jonesville, stated that he has lived on Tanbark for around a year, and has been down to this property ten to twelve times. He asked the Board to leave the access road to the river open and presented the Board with a petition signed by concerned citizens of the County.
Danny Rutherford, Jonesville, addressed the Board in opposition of the road closure.
Carl Orr. Jonesville, stated that he has floated the river for years and got in and

Carl Orr, Jonesville, stated that he has floated the river for years and got in and out at this location. He also stated that the Fire Department needs emergency access to the river and if this road is closed the Department would have to search for a location to access the river.

Randy Crumley, Jonesville, stated that he has floated the river all his life and it is harder now to find places to get in and out, he asked to Board to vote against this request.
Johnny Lakins, Rose Hill, addressed the Board in opposition of closing this road, stating that he was under the impression that Lee County had a strong emphasis on tourism, recreation and inviting people into the County.
Jacob Harris and Dennis Grizzle, Jonesville, presented the Board with a plat that showed Mr. Grizzle's right-of-way across the Estes property and addressed the Board about it being illegal to gate a public highway and block right-of-ways.
Ed Johnston, Jonesville, stated these bridges and fords are part of the County's history and should remain open for historical reasons.
Lena Bledsoe, Jonesville, stated that several people use this location and asked that the Board leave the road open.
Roger and Gail Waddell, Jonesville, stated that this property is within walking distance of their home and they walk to it often and asked that the Board not cater to one person when so many people use this location.
Rick Stafford, Stickleyville, stated that this swinging bridge has historical value and asked that the location remain open.
Skylar White, Pennington Gap, stated that he can drive his truck all the way down to the river and has caught many fish in that area and asked that this location remain open.

Michael Dunn, Pennington Gap, stated that closing this access for another would add three to four hours onto a float, which would make it harder for people to be able to do so, and asked that this location be left open.
Kathy Harris, Jonesville, stated that her children and grandchildren have enjoyed playing at the river and is opposed to the closing of this road and asked that the Board vote no.
Britni Harris Early, Jonesville, stated that if the property is opened back up at a later date it could lead to more illegal activity.

RESIDENTIAL ANTI-DISPLACEMENT AND RELOCATION ASSISTANCE PLAN

Lee County will replace all occupied and vacant occupiable low/moderate-income dwelling units demolished or converted to a use other than low/moderate-income dwelling units as a direct result of activities assisted with funds provided under the Housing and Community Development Act of 1974, as amended. All replacement housing will be provided within three years of the commencement of the demolition or rehabilitation relating to conversion.

Before obligating or expending funds that will directly result in such demolition or conversion, Lee County will make public and advise the state that it is undertaking such an activity and will submit to the state, in writing, information that identifies:

- 1. a description of the proposed assisted activity;
- 2. the general location on a map and approximate number of dwelling units by size (number of bedrooms) that will be demolished or converted to a use other than as low/moderate-income dwelling units as a direct result of the assisted activity;
- 3. a time schedule for the commencement and completion of the demolition or conversion:
- 4. the general location on a map and approximate number of dwelling units by size

(number of bedrooms) that will be provided as replacement dwelling units;

- 5. the source of funding and a time schedule for the provision of replacement dwelling units;
- 6. the basis for concluding that each replacement dwelling unit will remain low/moderate-income dwelling for at least 10 years from the date of initial occupancy; and
- 7. information demonstrating that any proposed replacement of dwelling units with smaller dwelling units is consistent with the housing needs of low-and moderate- income households in the jurisdiction.

Lee County will provide relocation assistance to each low/moderate-income - household displaced by the demolition of housing or by the direct result of assisted activities. Such assistance shall be that provide under Section 104 (d) of the Housing and Community Development Act of 1974, as amended, or the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

Lee County's FY 2020 The Fields Phase II Water Line Replacement Project includes the following activities:

- Installation of 1,713 LF of4-inch water line (PVC)
- Installation of 110 LF of 4-inch water line (DI)
- Installation of 3,033 LF of 2-inch water line
- Installation of 415 LF of 1-inch water line
- Installation of 2,500 LF of 3/4-inch service line
- Connection of 36 homes to the replacement water lines
- Related appurtenances

The activities as planned will not cause any displacement from or conversion of occupiable structures. As planned, the project calls for the use of existing right-of-way or easements to be purchased or the acquisition of tracts of land that do not contain housing. Lee County will work with the grant management staff, engineers, project area residents and the Department of Housing and Community Development to insure that any changes in project activities do not cause any displacement from or conversion of occupiable structures.

In all cases, all occupiable structure will be defined as a dwelling that meets local building codes or a dwelling that can be rehabilitated to meet code for \$12,500 or less.

BE IT KNOWN by all persons that the following Proclamation of the Board of Supervisors of Lee County, Virginia, endorsing the concept of Fair Housing, was duly adopted and approved on the 16th day of March 2021:

WHEREAS, discrimination in the sale, purchase, rental, or financing of housing against any person on the basis of race, color, religion, national origin, sex, age, familial status, disability, veteran status, gender identity, sexual orientation, or source of funds is prohibited by Lee County; and

WHEREAS, Lee County does hereby designate Mr. Dane Poe, County Administrator, as the Fair Housing authority to investigate all complaints of fair housing discrimination;

NOW THEREFORE, BE IT RESOLVED, that Lee County, Virginia,

- Endorses the concept of within Lee County
- Adopts the month of April 2021 as Fair Housing Month.

PROPERTY DONATION OFFER

Mr. Poe reported that he has received an offer from property owners to donate seven parcels of property to the County. These parcels were purchased at State Escheat Sales in 1989 and 1991. Several of these parcels are in the Penn Lee area between Stone Creek and St. Charles, one is located in the Pocket area near Stone Creek and one is located on Wallens Ridge. Mr. Poe sees no benefit to the County in owning any of these properties.


