The Chairman stated anyone wishing to make a comment should state their name and address and limit their remarks to three minutes.

JMB INVESTMENT CO. SPECIAL USE PERMIT REQUEST

The Lee County Board of Supervisors held a Public Hearing on October 18, 2022 at 5:30 p.m. in the General District Courtroom of the Lee County Courthouse located in Jonesville, Virginia to solicit input on a Special Use Permit request. JMB Investment Co. has applied for a Special Use Permit to allow a retail store in an A-1 Agricultural District. The property consists of approximately $2.19\pm$ acres and is located at the intersection of US Highway 58 (Wilderness Rd) and Rte. 758 (Flanary Bridge Rd) approximately 5 miles west of Jonesville.

The Chairman opened the floor for public comment.

Mr. Jim Ribble, Alpha Land Surveyors of Tazewell TN., stated he would answer any questions.

There was no further public comment.

The Chairman closed the floor.

PUBLIC EXPRESSION

The Chairman opened the floor for public expression and advised each speaker to state their name and address and limit their remarks to three minutes.

Johnny Lakins, Rose Hill, stated he put a letter in the Powell Valley about the landfill. He understands we have a trash problem and hauling it out costs a lot of money. He stated if we need a landfill we should bury our own trash and no outside trash and the money saved should go back to the taxpayers.

Sharon Fisher, Stickleyville, stated today is the 50th Anniversary of the Clean Water Act. She wants to know what studies and inquires about environmental impact were done prior to voting. She suggested a Citizens Advisory Group to work with the Board. A professor at UVA Wise published a study and suggested that middle Appalachia may be the place people want to come to escape climate change. If we want to attract people to our area having private landfills isn't the way to go.

Jan Brown, Ewing, stated she knows we have a problem with garbage, but is concerned that we will lose control of our county. We could have a lot of garbage coming in from other areas and countries. We don't want to be known as a landfill county. Her request is the Board will rescind their vote and sit down with the public and work together to find a solution. She doesn't think this is a road we want to go down.

Richard Schuler, Dryden, stated on TV you see phone numbers for law firms about suing the government due to the water contamination at Camp Lejune. We don't have the financial means to do testing that needs to be done. He agrees with Ms. Brown and thinks we should take a second look.

Debi Artrip, Keokee, asked the Board if any of them or their families would benefit from a private landfill. She stated that the amendment came up quickly and all the Board Members will be held responsible if a landfill goes in. She stated the Board should reverse the vote and give the public an opportunity to speak and vote on it.

Amanda Hurd, Jonesville, attended the last meeting and felt that it wasn't right that the landfill issue was voted on after closed session without the public there. She checked the August 16, 2022 meeting minutes and saw that the Board voted for a public hearing on the landfill issue at that time. She stated the Board implied that they didn't know about the amendment. She said nobody wants a private landfill or wants their children and grandchildren poisoned. She asked the Board to protect our county.

Mr. Leonard stated he wanted to clarify her statement and said the amendment the Board wasn't aware of was concerning the recreational vehicles and utility buildings.

Amanda Kelly, Rose Hill, has concerns about the smell, health issues and dropping property values. She lives here, and is planning on having kids and buying a house, but this is making it difficult. She wants to be sure the entity controlling the garbage can be held accountable to the people.

Jeff Johnson, Jonesville, stated he has worked for trash-to- energy facility and if the trash is recycled it would be better. We will have hundreds of big trucks traveling our roads. It would have to be fenced properly, animals will carry garbage off and the trucks leave a mess. Sue Ella Kobak, Dryden, stated she did extensive research on the possibility of private landfills in the county over 30 years ago and they were not able to find a location that was suitable. She stated the county averages forty-five tons of garbage a day. She asked the Board to reconsider their decision.

Earnest Cooper, Stone Creek, stated everyone he has spoken to is opposed to a landfill. He stated the Board was voted in and could be voted out the same way. He said they need to do what the people want.

Marion Kegley, Pucketts Creek, stated people he knows have heard about this and want to sell out and leave. He stated that work had been ongoing for 20 years to clean up the water on Pucketts Creek. He said that Lee County is a beautiful area and asked the Board to not let this come in to the county.

Tammy Cooper, Stone Creek, stated most of the water in her area is well water and she feels like she didn't have a chance to speak. Ms. Cooper stated the Board needs to rescind their vote.

There was no further public comment.

The Chairman closed the floor for public expression.

Mr. Mosley requested to speak.

Sue Ella Kobak began speaking from the audience.

Mr. Mosley stated all the Board did was pass a resolution. He said if the county got cut off at Blountville they would not have anywhere to dispose of our trash. He also advised that the Board had not had any contact with anyone about a landfill in the county.

Ms. Kobak continued speaking from the audience.

Several people began speaking from the audience.

Chairman Leonard asked that order be restored to the meeting. Mr. Leonard stated that public expression was over and the Board would proceed with their meeting.

Mr. Kolb stated he would like to address the public.

Ms. Kobak stated she would respond if he spoke.

Mr. Poe advised Ms. Kobak that there is an order of business and a procedure that is followed and when public expression is over it becomes the Boards' meeting. The public cannot participate in every item on the agenda unless called on to do so by the Chairman.

Ms. Munsey stated that the Board members may address the public and advised Ms. Kobak that she had been allowed to speak and that Mr. Kolb was due the same courtesy.

Mr. Kolb stated he was not on the Board to make money. He agreed with Ms. Kobak on recycling and stated he would like for the board to revisit that subject. He stated he has no plans to open a landfill. He advised that he would hope to have a reputable company like Waste Management operate a landfill in Lee County. The county spends about eight hundred fifty-thousand dollars a year to haul and dispose of our trash. We could benefit financially if we would let the right person do it. He trusts the DEQ they would be constantly monitoring. He also advised that there would be another public hearing if someone proposed to do a landfill and the county can put stipulations on special use permits which would limit where trash could originate from. He stated the Board voted on the landfill issue during a very long meeting and it required legal counsel on some of the issues. He stated if someone wanted to come here to create some jobs that it would be a good opportunity.

Mr. Leonard stated the county is limited to only a few sites that would be eligible for a landfill and the people in his district know he has no interest in one.

The first truck is white with black interior at a cost of \$38,627.00, the second is blue with black interior at a cost of \$40,999.00, neither truck has running boards but they can be added at a cost of \$750.00, and a locking bed cover is an additional \$1508.50.

Mr. Smith asked where the property was located.

Mr. Poe stated it was near the former tractor dealership east of Rose Hill.

Mr. Kolb stated he would like to review the plat and discuss in closed session.

REPORTS AND RECOMMENDATIONS OF THE BOARD

ANIMAL CONTROL WEEKEND ROTATION

Mr. Smith asked Mr. Poe if Animal Control was rotating weekend work since all three employees are now full time.

Mr. Poe stated he would check on that.

WORK AT THE THOMAS WALKER POOL

Mr. Smith stated that Gary Collingsworth is currently removing trees around the pool and then will be working on the basketball court.

Mr. Kolb stated items not resolved should remain on the agenda until completed. He stated that Amy Greer from Mountain Empire Community College was supposed to propose a contract for the Promise Program.

Mr. Poe advised that this program would not start until the 2022-2023 fiscal year and Ms. Greer indicated they would submit a budget request at a later date.

Mr. Kolb stated he wants a guarantee that Lee High and Thomas Walker graduates can go for two years free under this program.

Mr. Poe stated he would advise MECC to include this in a contract.

OPIOID SETTLEMENT GUIDELINES

Mr. Kolb asked if the Opioid workshop has already taken place.

Mr. Poe stated the workshop was October 12th and they don't have specifics worked out yet.

Ms. Munsey stated she provided a copy of appropriate uses of the funds to Richard Johnson which were provided by the county's legal counsel.

Mr. Poe stated Virginia had one hundred percent participation of all cities and counties in the lawsuit which qualifies for extra funding. The county can partner with a provider of services but must oversee the work. Only state agencies, cities and counties will receive funding from the state. It will require partnerships with counties and the providers that can provide the services.

Mr. Kolb asked if there are any deadlines involved.

Mr. Poe stated there are no deadlines and the first two payments have been paid. The funds received to date are from the distributors. We are required to spend a minimum of eighty-five percent of the money received on Opioid Remediation. We qualify for eighty-five percent because we had initiated litigation prior to the settlement.

Mr. Kolb asked who will be the point person to brief he and Mr. Mosley.

Mr. Poe stated the parameters haven't been set yet and the Opioid Abatement Authority is still getting organized. Mr. Poe stated he would take the lead but it would be up to Mr. Kolb and Mr. Mosley to decide who they want to serve on the committee.

ST. CHARLES RESCUE SQUAD LEASE

Mr. Kolb asked the status of the Saint Charles Rescue lease.

Ms. Munsey stated she has worked on it but doesn't have a final agreement.

DSS LEASE PAYMENTS

Mr. Kolb stated in the last meeting he brought up the DSS lease payments. He doesn't believe they are paying as much as they should.

Mr. Poe stated he will check on that.

TREE IN DSS PARKING LOT

Mr. Kolb asked about the tree at DSS.

Mr. Poe stated that it's on the list of projects for the Solid Waste Dept. to complete.

Mr. Kolb stated the tree is now in the power lines.

Mr. Poe stated they will have to block off that area of the parking lot or take it down on the weekend.

STARLINK BROADBAND PROPOSAL

Mr. Kolb asked to be briefed on the Star Link Internet proposal.

Mr. Poe stated he would get that information.

RECODIFICATION PROJECT

Mr. Kolb asked the status of the county code update.

Mr. Poe stated he has draft back from the vendor and had given a copy to Ms. Munsey. He stated he has not reviewed it yet. They provided recommendations on things to be updated or changed to comply with state code. He also has to compile ordinances amended or adopted since they started the project for inclusion in the county.

Mr. Kolb asked Mr. Poe if he could provide a copy.

Mr. Poe stated he could.

PREPARATION OF DRAFT MINUTES

Mr. Kolb stated staff needed to do a better job of getting the draft minutes out in 10 days and the audio recordings posted to the website.

Mr. Poe stated the recording failed on the September meeting.

Mr. Kolb stated he referred people to the website but it was not there.

Mr. Poe stated we had to wait on Mr. Hartley's recording in order to prepare minutes.

Mr. Kolb asked if we could post that recording to the website.

Mr. Poe stated we could put a link to the YouTube video on our website.

EDA LOAN TO JOE BATES

Mr. Kolb asked if we had been paid back the money loaned to Joe Bates.

Mr. Poe stated that was an EDA issue and he does not have those records.

COUNTY BUILDING MAINTENANCE

Mr. Kolb stated the county has done a poor job keeping up old buildings in the county. He gave Ewing Elementary as an example. The School Board gave the building to the county, nothing was done with the building for a long time and was vandalized, and the building was sold for \$10,001. The same mistake was made with the School Board Office. Buildings in Saint Charles have been broken into. Mr. Kolb stated we need someone to periodically check on the old buildings. He suggested the building inspector do this when they are in an area and asked the Boards' thoughts on that.

Mr. Leonard and Mr. Mosley stated they did not have a problem with that.

Mr. Poe stated he thinks the vandalism to the Saint Charles buildings occurred before the County took ownership.

Mr. Kolb stated the last time he was there the EDA owned them and they weren't vandalized.
