All projects in the Secondary Six-Year Plan that are eligible for federal funds will be included in the Statewide Transportation Improvement Program (STIP), which documents how Virginia will obligate federal transportation funds.

ncreases in current project cost estimates. There is funding available in the new Countywide Transportation fund for studies and other projects.

Mr. Matticks stated that the Clear Springs project would begin next year and the Blue Springs project would be in 2027 and 2028.
Mr. Kolb asked if signs warning tractor truck traffic to avoid Route 70 could be blaced on Route 58.
Mr. Kolb asked about signage at the Lee Farmers Cooperative.
Mr. Matticks stated that he had discussed this matter with the Coop manager and hey were hesitant due to parking issues.
Mr. Kolb asked if the roundabout could be eliminated from the Pennington Gap project and just do a turn lane along that corridor.
Mr. Poe advised that the roundabout and turn lane were packaged together in the pre-application and that the Town of Pennington Gap supported the roundabout.
