The Chairman called the meeting to order at 5:04 p.m.

REPORTS AND RECOMMENDATIONS OF THE COUNTY ADMINISTRATOR

BUDGET WORKSESSION

Mr. Poe provided a timeline for budget adoption prior to July 1 including the latest public hearing date, advertising requirements and additional public hearings if a tax rate increase is being considered. He advised that he had budgeted ARPA funds expenditures in an amount equal to the additional funds to be received in the 2022-23 fiscal year. He provided general guidelines on the expenditure of ARPA funds, advised that some revenue estimates had been increased but most are the same as the previous meeting's estimates. He also advised that the revenue projection for personal property was based on the full amount of the increase in used vehicle values. He advised that the budget now has a projected deficit of approximately \$2.6 million but this could be reduced with some of the expected adjustments the Board may want to make.

Mr. Leonard asked where most of the deficit increase came from.

Mr. Poe advised that part of it was due to general price increases, high fuel costs, an increase of \$200,000 in jail costs coupled with a decrease in the jail true-up refund of about \$600,000, plus the \$200,000 request from the EDA.

Mr. Mosley asked why they needed \$200,000.

Mr. Poe advised that their annual costs are approximately \$25,000.

The funding request of Spearhead Trails was discussed regarding whether the County was receiving any benefit. There was some discussion on the possibility of providing those funds to the Town of Pennington Gap.

Mr. Mosley questioned the amount of some of the salary requests.

Mr. Leonard stated that he agreed that some employees deserved a bigger raise than others.

Mr. Poe advised that performance evaluations would require the development of a performance measurement tool.

There was a general discussion on employee salaries and how best to address the matter for the upcoming budget.

The Board directed Mr. Poe to calculate county employee raises on an average of 3% excluding Solid Waste employees.

The Board then reviewed various capital outlay requests and outside agency requests.

Sidney Kolb joined the meeting by phone at 6:18 p.m.

Mr. Leonard left the meeting at 6:35 p.m. due to a family emergency.

Mr. Kolb commented that expenditures keep rising but nothing is being done to increase revenues.

Mr. Kolb entered the meeting at 6:45 p.m.

EDA REQUEST FOR DRAW FROM ECONOMIC DEVELOPMENT FUND

Mr. Poe provided a recap of the Board's previous discussion on this matter. It was general consensus to not use the Economic Development Fund for this expense. The EDA has since met and requested the Board consider using ARPA funds to make the repairs.

It was moved by Slemp, seconded by Mr. Smith, to approve funding for the EDA's Dryden building HVAC repairs quote and shipping costs to come from the County's ARPA funds. Upon the question being put the vote was as follows.

PROPOSAL TO INCREASE SELECT BUILDING PERMIT FEES
